OVERVIEW

Obesity is pandemic. Morbidity and mortality from obesity has exceeded that of smoking. It affects socioeconomic class, age and gender equally and is akin to the modern plague. Medical costs associated with obesity range as high as \$209.7 billion and account for more than twenty percent of all annual health care spending in the United States. Treatments include behavioral modification, medical therapy and surgical interventions.

With new pharmacotherapies coming to market and an increasing number of bariatric surgeries, providers need to be aware of the unique needs of bariatric patients, especially following bariatric surgery.

This conference will offer insights to effective management of obese patients and will look closely at weight loss medications, new medical therapies and surgical options, obesity in

pregnancy and childhood, and the management of the post-bariatric surgery patient, especially post-surgical hypoglycemia.

TARGET AUDIENCE

This course is designed for internal medicine and primary physicians, pediatricians, endocrinologists, obstetrician/gynecologists, surgeons, hospitalists, nurses and nurse practitioners, physician assistants, dietitians, pharmacists, scientists and all other healthcare professionals that interact with and help treat the morbidly obese patient.
